

# LIVING EXCHANGE AGREEMENT — “Value Of Freedom Token”

An agreement to uphold the free, honorable exchange of Value (through the Value Of Freedom Token) among Living men and living women. The presumptions are that prior to acquiring the Value Of Freedom Token you agree to this Living Exchange Agreement. You are free to record your explicit consent too.

**Purpose:** This Living Exchange Agreement affirms the shared understanding between Living men and Living women of peace and honor that value — in all its sacred forms — may be freely given, received, and recognized outside the control of systems built upon debt, coercion, or artificial (statutory) law.

We hereby bring forth the “**Value Of Freedom Token (LIFE)**” — a digital instrument of Value Exchange, rooted in trust, goodwill, and real life energy — not as a currency and not as legal tender, but as an Exchange of Value, a **symbol of offering, appreciation and care** within a **Circle of Freedom** completely and entirely under Natural Law.

## Nature of the Value Of Freedom Token (VOF Token):

- It is created and acquired only by Living men and Living women in the private domain.
- It holds no connection to statutory law, legal or commercial systems, and claims no allegiance to corporate constructs.
- Each VOF Token represents a **gesture of Life Energy** — whether labor, food, teaching, care, healing, or any sacred act.
- It is recorded through private, blockchain-based technology as a Living Ledger — not to track ownership, but to honor Exchange of Value (Life Energy).

## Guiding Principles:

1. No Living Being is obligated to accept, gift or exchange the Value Of Freedom Token — they are offerings through Value Exchange, not obligations.
2. No interest, no debt, no taxation, no enforcement shall ever be attached to this Exchange of Value.
3. All use of the Value Of Freedom Token exists in or live under this Living Exchange Agreement, in the Private as a tool under Natural Law for the Living men and Living women who walk in honor and goodwill.
4. This Accord recognizes the Divine right to self-organize, to value life authentically, and to reject any system that seeks to enslave and/or control value or perpetuate and/or uphold debt.

This accord is eternal in spirit, yet flexible in form. It shall evolve as the heart of the Living men and Living women open up and as Private Assembly Agreement and/or the quantity of Circle's of Freedom expand.
